2022 Task Force Research: Sneak Preview!

Planning, Land Use, Transportation & Infrastructure: The region has seen rapid growth in the transportation and logistics sector. Significant new industrial development has occurred or is planned, reducing the quantity of readily developable open space suitable for these uses. As other neighboring regions like the Lehigh Valley exhaust their supply of cost-effective open space suitable for industry, the region can increase its economic competitiveness by looking toward repurposing of older industrial buildings or redevelopment of brownfield sites as an alternative to Greenfield development. This study will articulate the benefits of such reuse related to sustainability, infrastructure, public services, and transportation and explore regional and nationwide case studies of successful projects. The report will also analyze barriers to reuse and successful programmatic or policy approaches to help overcome these barriers. Finally, the study will analyze existing land inventories to identify areas of greatest opportunity.

Jobs, Economy & Economic Development: Even prior to COVID-19, non-skill barriers to workforce participation, like lack of transportation, lack of childcare, and family caregiving responsibilities, were important factors in the region's labor market. This study will examine regional, state, and national workforce participation data over time by age and gender (including COVID impacts, as available data allows), and draw upon literature to show the dynamics of the decision to participate in the workforce. Within the context of a tight and rapidly shifting labor market and ongoing retirement of the Baby Boomer generation, research and case studies will be prepared on potential programs or policies to help overcome these barriers and help connect those outside the labor force, particularly parents and other caregivers, with opportunities to build family economic security and meet the needs of local employers. Recommendations will be identified by stakeholder groups, including potential industry-specific recommendations.


Housing: The region has seen signs of recent population growth, and in order to maintain naturally affordable, achievable housing for working-class and middle-class households, there will likely be a need for new housing and revitalization and/or reimagining of existing housing. This policy-oriented report will further define these needs and explore several methods of providing quality, unsubsidized housing that is affordable to NEPA's working families. This will include federal, state, or nonprofit programs to rehabilitate and return to use aging, blighted, or foreclosed homes, adaptive reuse, land use barriers to new housing construction, and employer-driven interventions.

Health & Health Care: This report will explore the impacts of social isolation on health and how the COVID-19 pandemic exacerbated social isolation among various segments of the population, including older adults, children, and families. A broad-based literature review will summarize findings on these impacts, including aspects such as child abuse and neglect, domestic violence, and behavioral health. Additionally, secondary data on pertinent health indicators will be analyzed, and a regional perspective will be gleaned through interviews with stakeholders in health, social services, and education.

Energy: Shifting energy production to non-fossil fuel energy sources (including nuclear and renewables) has been emphasized by policymakers and business leaders alike in order to mitigate greenhouse gas emissions. Industries centered on transportation, such as Northeastern Pennsylvania's logistics sector, are key stakeholders in these efforts as major users of energy. The environmental and economic impacts of electricity and natural gas are researched and compared to alternatives in order to determine best practices.

Education & Workforce Development: Several disruptions have impacted education and workforce needs internationally, nationally, and in Northeastern Pennsylvania. This report will examine how these disruptions have impacted students, teachers, and education and workforce training institutions. It will include a background analysis of long-term industry trends and industrial automation, literature review of COVID-19 impacts on K-12 and postsecondary education, and primary data collection in the form of educator surveys and/or focus groups to gather local-level impact data on how the pandemic affected students, and interviews with postsecondary and workforce development stakeholders to connect pandemic impacts with long-term challenges to the talent pipeline. Finally, programmatic and policy recommendations will be developed to alleviate short-term challenges faced by students and teachers and ensure long-term competitiveness in the evolving economic landscape.


